Biographical Sketch:

James Andrew Aikens was born on July 21, 1860 in Pictou, Nova Scotia. He worked for the Canadian Pacific Railway, first as a brakeman and later as a conductor. Aikens was married to Mary Sophie McKenzie, and was involved in the Kamloops I.O.O.F. (Tatnai Lodge) and the Canadian Order of Foresters. James Andrew Aikens died on May 28, 1934 in Kamloops, BC at the age of 73.

Mary Sophie Aikens (nee McKenzie) was born on August 15, 1865 in Pictou Landing, Nova Scotia. She was married to James Andrew Aikens. Mary Sophie Aikens (nee McKenzie) died on January 17, 1941 in Kamloops, BC at the age of 75.

Scope and Content:

Fonds consists of photographs collected by James Andrew and Mary Sophie Aikens. Collection is predominantly comprised of images related to the Canadian Pacific Railway in Kamloops and the surrounding region and includes portraits of employees.

Custodial History:

Collection was donated to the Kamloops Museum and Archives at an unknown time (presumed prior to 1964) by Mrs. J.A. Aikens (Mary Sophie Aikens, nee McKenzie). Materials in this collection were formerly integrated into the KMA Photograph Collection at the time of donation, and were reprocessed as a distinct collection during reprocessing in 2022. Portraits of CPR employees were removed from the collection in January 2004 by former KMA employees and slated for deaccession, but were reintegrated during reprocessing.
