Biographical Sketch:

Chan Ah Mee was a Chinese businessman who ran various enterprises in Kamloops, B.C., including a wash house, a laundry, and the Elk Hotel on the North Thompson. He was married to Cherry Jip Ti He in 1891, with whom he had a son (Jim). Chan Ah Mee died in Kamloops following a car accident in 1926.

Scope and Content:

Fonds consists of correspondence, receipts, bills, tax assessment notices, cheques, and a business license from Chan Ah Mee.

Custodial History:

All accessions were previously placed in the Vertical Files Collection separately, and were brought together into the Chan Ah Mee fonds during reprocessing in 2019. None of the materials have donor information.
