Administrative History:

The Canadian Club of Kamloops was established in 1927, as a branch of the Canadian Club. The Club sponsored forums and invited speakers to discuss current events, scientific topics, and cultural affairs. The Club was dissolved in 1984.

Scope and Content:

Fonds consists of minutes, correspondence, membership lists, financial records, reports, newsletters, speeches, and clippings relating to the Canadian Club of Kamloops and its sponsored events.

Custodial History:

Fonds was originally made up of accession 1984.012, with additional materials being accrued during reprocessing in 2019 (accession 1995.028.007).

Accession 1984.012 was donated to the Kamloops Museum and Archives on February 9, 1984 by Fred Shirley, the last acting president of the Canadian Club of Kamloops.

Accession 1995.028.007 was donated on July 10, 1995 by Meryl Matthews.
