Biographical Sketch:

Whitfield Chase was born in Sidney, Delaware on November 9, 1819. He received training at the Delaware Literary Institute in Franklin, New York, before moving to Oregon in 1852 to practice the trade of carpentry. Chase ventured briefly to California before turning north and travelling to Vancouver Island to work as a carpenter. In 1859 Chase was beginning to contemplate travelling again, considering returning to California before eventually settling on trying his luck as prospecting on the South Thompson River. Despite extensive travels, Chase and his prospecting partner Donald McPherson did not find success in the gold rush. Chase then gained employment with the Hudson's Bay Company in the Cariboo region, working at a variety of jobs until he had saved up enough money to settle. By 1865 Chase had settled in the Shuswap area near present Chase (named in his honour) with the idea of settling down to work the land, becoming the first non-native settler to the area. At this time he married a First Nations woman named Elizabeth, the daughter of the Neskonlith Indian Band Chief Synsetia. The couple would have 10 children: four sons (Ulysses, Marcus, Hubert, and David) and six daughters (Ann Sarah, Ellen Grant, Minerva, Amy, Catherine, and Lillian). Chase's ranch and orchard would be the first in the area, and was very successful, allowing him and partner McPherson to establish a general merchandise company (W. Chase and Company) and invest in a hotel. Whitfield Chase died in 1896 at the age of 77.

Scope and Content:

Fonds consists of photocopies and typescripts of the personal papers of Whitefield Chase. Records include various reports, financial records, correspondence, and ephemera.
