### Biographical Sketch:

**Mary (Margaret) Spencer** was born in 1857 in Dunnville, Ontario, the daughter of Margaret and Abraham Spencer. The family moved to St. Catharines, Ontario in 1857, where Mary would begin her studies in art and photography. In 1890 Mary would move with her mother Margaret and sister Isobel to Port Colborne, before relocating to Kamloops, B.C. in 1899. Spencer soon opened a photography studio in Kamloops, also offering oil painting classes. Spencer's portraits became popular amongst Kamloops notables and many of her scenic images of the Kamloops area were made into postcards and souvenir books. In May 1906 Spencer was hired by the Vancouver Daily Province to cover the capture and trial of train bandit Bill Miner, earning her an even bigger reputation as an early photojournalist. In 1909 she sold the business to Mrs. L.M. Walker, and moved to Summerland, B.C., with her sister Isobel to run an orchard. Mary re-established a photography studio, but did not see the same success in Summerland as in Kamloops. Spencer died in 1938 in Summerland, B.C.

### Scope and Content:

Collection consists of photographs by Mary Spencer and originating from her studio, as well as postcards and souvenir booklets produced from her images.

### **Custodial History:**

The bulk of the collection was donated to the Kamloops Museum and Archives at an unknown date by Mary Spencer's sister, Isobel Spencer. Negatives were also salvaged from Spencer's studio by C.A. Lapham, from which prints were made and added to this collection by the staff of the KMA. Additional photographs from various donors were initially added to this collection by staff of the KMA, but during collection reprocessing in 2018 photographs from large collections belonging to specific donors were returned to their original collections and individually donated materials remained in this collection. ### Notes:

**Source of supplied title:** Title based on contents of fonds.

**Arrangement:** Original arrangement of the collection was imposed by the archivists of the KMA, as individual photographs were originally placed generally in the Photograph Collection. Photographs from Mary Spencer and her studio were separated from the Photograph Collection during reprocessing in 2015 to coincide with an exhibition about Mary Spencer. During reprocessing of the collection in 2018 photographs from large donations from specific individuals were returned to their respective collections, and the remaining collection was arranged into three series based on source of donation – Isobel Spencer, C.A. Lapham, and Other. KMA Photograph Collection numbers retain original arrangement by KMA archivists.
