Administrative History:

The Thompson River Improvement Company was established in 1904 by local sawmill operators John and James C. Shields, and business partners George W. Fowler, George McCormick, William Irwin, and Peter Ryan. The company's purpose was to operate a log boom and carry out related logging activities on the Thompson River near Kamloops Lake.

Scope and Content:

Collection consists of records related to the Thompson River Improvement Company. Records include letters and petitions of protest against the activities of the company and publications by Parliament related to the company's incorporation.

Custodial History:

Accessions 0.3095 and 0.3098 have no available donor information. Records were formerly placed in the Vertical Files collection and were brought together as a distinct collection during reprocessing in 2020.
