Administrative History:

Wilcox-Hall Company was a hardware store in Kamloops, B.C., operated by partners E.M. Wilcox and James W. Hall. In 1912 the company bought Hargreaves' store, and expanded in 1917 to operate the Maxwell Motor Car agency. In 1930 the company was under new management (N.S. Dalgleish), changing again in 1934 (T. Crichton Campbell), and in 1949 the company joined the Marshall-Wells chain of stores.

Scope and Content:

Fonds consists of a ledger of accounts and four advertising cards for the Wilcox-Hall Company.

Custodial History:

Accession 1982.036 was donated to the Kamloops Museum and Archives on June 2, 1982 by Tom Wilcox, presumed to be a relative of E.M. Wilcox.
